- Following a resolution by Marge Brown, seconded by Sui-Ling Ruiz, the board unanimously approved the hiring of Madison Watson as Library Page at \$11.10 per hour with a start date of 10/16/2018.
- On a resolution by Barbara Winfield, seconded by Sui-Ling Ruiz, the board unanimously approved to accept the \$16,500 bid from DJS Plumbing and Heating to replace the boiler at the Delaware Free Branch.
- Marge Brown made a motion, seconded by Pam Reinhardt, to accept the resignation of trustee Matt Solomon. The motion passed unanimously.
